

#### ANNUAL NORTHWEST REGIONAL FIDDLE CONTEST RULES

- Contestants will first play a hoedown, second a waltz, and third a tune of choice other than a hoedown or a waltz. No tune may be played more than once during al appearances at the contest.
- 2. Actual playing time shall be limited to 4 minutes as heard by the judges. A timer will be placed in the judges room and for every 30 seconds over, 10 points will be deducted from the total score.
- All contestants shall draw when they register for inital order of appearance. In future rounds, drawing will be by proxy. Contestants must be ready when called. No seeding or qualifing rounds in any contest.
- No amplified instruments or contact microphones will be permitted.
- 5. No trick or fancy fiddling allowed during appearances.
- 6 . All decisions of the judges and contest committee will be final.
- 7. Any danceable folk tuneplayed in old time fiddle fashion is acceptable.
- 8. Contestants may play without accompanist or not more than two.
- Judging will be scored for oldtime fiddling ability, danceability, rythm, or timing, and tone quality. All scores will be accumulative. Points will be deducted for any violation of the rules.
- 10. Any protest must be submitted in writing to the contest chairman and signed by not less than three contestants of the contest involved, within three hours of protest occurance.
- 11. If anyone appears intoxicated, they will not be allowed on stage.
- 12. If a string breaks, the FIDDLER will have the option to continue or stop at that point. If the tune is completed it will be judged as played. If the fiddler stops play he will be allowed to begin with that tune and complete his program.
- 13. Only residents from the following States and Provinces are eligible for this Contest. Washington, Idaho, Montana, Oregon, North & South Dakota, Wyoming, Alaska and the area lying West of the Saskatchewan and Manitoba borders in Canada.

SENIOR DIVISION, 10.00 entry fee 1st -5th place; LADIES DIVISION, \$10.00 entry fee, 1st-5th place; JUNIOR DIVISION, Entry Fee \$10.00 1st-5th place; JUNIOR-JUNIR, Entry fee \$5.00 1st-5th place; MENS DIVISION, Entry Fee \$10.00, 1st-5th place; CHAMPIONS DIVISION, \$15.00 Entry fee, 1st-5th place. All receive money prize with trophy.

## ALSO: Hokum Contest

A five minute fiddle oriented showmanship contest, using acoustical instruments with as many accompanist as you choose. You may play whatever tune or tunes you like within the five minute time allotment.

The hokum contestant will play only once at conveniently scheduled intervals throughout the contest.

Three top winners will receive trophys, and will be judged on their showmanship, dress and music ability.



## OREGON OLDTIME FIDDLERS ASSOCIATION OFFICIAL STATE CONTEST - STANDING RULES

#### CONTEST DIVISION

- A. Championship Division
- B. Intermediate Division
- C. Senior Division
- D. Junior Division
- E. Junior-Junior

#### DIVISION RULES

- A. Championship Division
  - a. Includes contestants eighteen (18) years old and less than sixty-five (65) who have placed as follows:
    - (1) In top twenty (20) of Championship Division at Weiser.
    - (2) In top three (3) of Ladies Division at Weiser or Certified Regional Contest.
    - (3) In top five (5) of any State Championship Division.
    - (4) Any other contest who qualifies by age and who feels qualified, may enter the Championship Division.

Exception: Any person placing first in the Intermediate Division of the Oregon State Contest must compete in the Championship thereafter. If such contestant does not make the first elimination in the Championship Division at the State Contest two years in a row, he may drop back to Intermediate Division competition the follown (or third) year.

- b. Contestants who participate in the Championship Division shall be expected to actively participate at fiddling function during the year including fairs, shows and the state convention.
- c. The first place winner in the Championship Division will be expected to represent the OOTFA at the National Contest at Weiser, Idaho in June. In the event that the reigning champion establishes residency in another state, or for other reasons cannot represent the OOTFA during the year in the State of Oregon or at the National Contest, a reserve Champion will be selected by the Board of Directors as a substitute. This Reserve Champion will be the second place winner in the Championship Division. Should the reserve Champion not be able to attend, then a Reserve Champion will be selected in top order of placem ent in the Championship Division at the State Contest.
- B. Intermediate Division
  - Includes all contestants eighteen (18) years old to sixty-five (65).
  - b. Includes all contestants not qualifying for Championship Division.
- C. Senior Division
  - a. Includes all contestants sixty-five (65) years of age or older.
- D. Junior Division
  - a. Includes all contestants under eightee (18) years of age not not qualifying for Junior-Junior Division.
- E. Junior-Junior Division
  - a. Includes all contestants under thirteen (13) years of age.

# OREGON OLDTIME FIDDLERS ASSOCIATION OFFICIAL CONTEST RULES

- 1. Participants in the Oregon Oldtime Fiddling Contest shall;
  - A. Have resided in Oregon permanently for six (6) months prior to the contest date.
  - B. Hold a current valid OOTFA membership card for a six (6) months period prior to the contest date.
  - C. Qualify for competition by payment of entry fee as established by Contest Chairman and may play in one division only.
- 2. At registration, all contestants shall draw for inital order of appearance for the first preliminary round. Contest Chairman in further rounds will draw before each round for new order of appearance.
- 3. Contestants at each appearance must first play a hoedown, secont a waltz, and third a tune of their choice other than a hoedown or waltz. No tune shall be played more than once during all appearance of a contestant. Suggested total playing time is four (4) minutes. Points will be deducted if playing becomes monotonous or repetitious.
- 4. Contestants may play without accompanist or with no more than two.
- 5. Any danceable folk tunes played in Oldtime Fiddle fashon are acceptable.
- 6. Contact microphones and amplified instruments will not be permitted.
- 7. No trick or fancy fiddling will be allowed during the contesting appearance.
- 8. Judging will be scored for Oldtime Fiddling Ability, Rhythm or Timing, and Tone Quality. All scores will be accumulative. Points will be deducted for my violations of the above rules #3 through #7, inclusive.
- 9. Any protest must be submitted to the Contest Chairman and signed by not less than three contestants of the contest involved within three (3) hours of the protest occurance.
- 10. Judges will be selected by Contest Committee and will number either three (3) or five (5) at the discretion of the Committee.
- 11. All decisions of the Judges and of the Contest Committee will be final.
- 12. All other considerations, such as payment of registration fee at the National Contest and determinations regarding residency and eligibility will be made at the discretion of the Board of Directors of OOTFA.
