

A recent article in the NOTFA paper talks about humidity and the "health" of your fiddle. In addition to the proper care of your instrument, the moisture in the air also contributes to its staying in tune. Probably one of the most important factors in group playing is that of everyone having their instruments tuned together. It is difficult enough for a group to maintain the identical notation and tempo while playing, but when someone is "out of tune" with the rest, the total sound can be disastrous.

In the first place, someone must determine what everyone must tune to, whether it be to the piano on stage (check it for pitch before making that decision), to pitch pipes or electronic tuners (which are the most accurate).

Then check with each other after you think your strings are in tune.

When you first remove your fiddle from its case, you change it to a different temperature and atmosphere. The cased instrument may have been quite cool and come out into a warm room, or warm from being taken from your car in the summer heat and it comes out into a nice cool breeze. Any drastic change, from warm to cool or cool to warm, can have a distinct influence on the tuning. Maybe your fiddle was in tune last night, but it probably has gone through a minimum of 35 degrees (twice) in temperature changes since then.

Check your tuning pegs. Some fit just right and hold your tuning tightly, while others have a tendency to slip. You can apply a bit of bow resin inside to help keep them from slipping. Fine tuners are inexpensive, and worth their weight in gold, but their range is minimal if your pegs are slipping.

If you HAVE to play out in the sun, which we try to avoid, remember that top of your fiddle will be warmer, with the sun shining on it, than the bottom, and this can not only affect the tuning, but affect the finish on

your instrument

Now please don't anyone be offended, but if you have a known hearing loss be aware of the range of loss. If your problem is in the higher decibals (pitches) you will have difficulty hearing if your higher strings are tuned properly, and if your loss is in the lower decibals, your lowerstrings will be a tuning problem for you. Perhaps you could get another player to help double-check your tuning before you play.

And don't forget that just a lot of playing will change your tuning. Each time you pull that bow across the strings you are putting pressure and stretching them. And pressure can pull the strings out of tune. CHECK

YOUR TUNING OFTEN, don't just tune once and forget it.

To sum up, be aware that moisture changes in the atmosphere, temperature changes, slipping pegs, inaccurate hearing and just plain playing can make a great difference in how your fiddle is tuned or stays in tune. So.... keep checking your tuning, and, for goddnes sake, KEEP FIDDLIN'!!!
