CONTEST RULES:

- 1. All participants must reside in Oregon permanently for six (6) months prior to contest date.
- 2. All must hold a current valid individual OOTFA membership card for six (6) months period prior to contest.
- 3. They must qualify for competition by payment of entry fee as established by the Contest Chairman and Committee.
- 4. May play in one (1) division only. (Twin fiddling not counted.)
- 5. If there are any complaints, you must bring them to the Contest Chairman within three (3) hours and signed by not less than three (3) other contestants that are involved.
- 6. All decisions of Judges and Contest Committee will be final.
- 7. You may have one (1) or two (2) accompanists only or none.
- 8. No trick or fancy fiddling will be allowed during the contesting appearances.
- 9. Judging will be scored for old time fiddling style, rhythm or timing, tone quality & danceability. 25 points each. All scores will be accumulative.

(Total score sheets available for \$1.00 each paid with entry fee.)

- 10. No contact microphones and amplified instruments will be permitted.
- 11. Contestants at each appearance must first play a HOEDOWN, second a WALTZ, and third a TUNE OF CHOICE OTHER THAN A HOEDOWN OR WALTZ. No tune shall be played more than once during all appearances of a contestant.
- 12. Four (4) minute time limit will be in force.

TWIN FIDDLE CONTEST RULES

In addition to the General Contest Rules, the following rules apply specifically to the Twin Fiddle Contest:

- 1. DIVISIONS This contest is open to all ages and to both sexes. There is only one division.
- 2. A contestant may enter this contest only once.
- 3. TUNES This contest is limited to one tune. However, a medley is acceptable. There will be one round unless there is a tie. In the event of a tie, a different tune must be played by the teams involved, other than the tune previously played by that team.
- 4. TIME Three minutes playing time will be strictly adhered to. Ten points will be deducted from the total score for every 30 seconds or portion thereof over three minutes, ten seconds.
- 5. ACCOMPANIST Not more than three accompanists may be used. Accompanist may not play the melody of the tune.
- 6 Judging will be based on the following:

A. Rhythm and Timing - 25 points

B. Difficulty and Arrangement of piece - 25 points

C. Appropriateness of harmony and unison of bowing
D. Intonation & Clarity of Tone

- A. Contestants should play their tune at the proper speed for the selection, the tempo should remain constant, and the playing should be danceable.
- B. An intricate tune will score higher than a simple on in this category. A tune which requires greater technique will be awarded more points in this category.
- C. Harmony should be appropriate to the chords of the tune and long passages of unison notes should be avoided. Points will be deducted if one player plays alone for more than a few notes. Twin fiddlers should use their bows to phrase similarly or in a manner which complements their partner's playing.
- D. Notes should be clear, precise, and in tune. Deductions will be made for squeaks or for scratchy tone. The tastefulness the harmony notes selected will be considered in awarding points in this category.

These rules will be in used for the 1989 Oregon Old Time Fiddlers' State Contest to be held June 2 & 3, 1989 in Lebanon. Refinement will follow with final adoption to be proposed at the State Convention in 1990.
