**Site Assignment**

**Extra Vehicles**

All vehicles in addition to the initial RV unit (towed vehicles are considered part of the RV unit)  
 All Extra Vehicles must be registered and park in the Dry Camp area if they don't fit in the site.  
 RV Units are not considered Extra Vehicles and must purchase a site.  
 Extra Vehicles can pay upon arrival.
